**Re: Conan Doyle Medical Centre and GP services in Liberton and Gilmerton**

I am responding to your most recent letter regarding GP services in Liberton and Gilmerton date 6<sup>th</sup> September 2023.

It is incredibly disingenuous to suggest that the dearth of available GP services in Edinburgh South is somehow the responsibility of NHS Lothian.

The business case for the development of a medical practice as part of the Liberton Campus development, was scheduled to go to the NHS Lothian Capital Investment Group (LCIG) on 23<sup>rd</sup> February 2023, on the way to submission to the Scottish Government. The case was put before the Edinburgh Integration Joint Board and was supported by them.

In early February NHS Lothian withdrew the paper as a direct result of advice received from Scottish Government, that a 'pause' with immediate effect had been imposed on all NHS capital development which had not already been legally committed to.

To direct me and my constituents to NHS Lothian to find answers to the GP crisis is facetious, after NHS Lothian warned over a decade ago of 'failure' in Edinburgh GP services if the Scottish Government did not step in.

Edinburgh's population has grown by 8,000+ each year over the last decade, partly facilitated by Scottish Government permitting large scale developments at appeal, even when the council has raised questions about how public services will keep up with population rises.

Your government has never provided increases to capital budgets in Edinburgh
